Counter Notification of Copyright Infringement

We cannot and will not pass judgment on alleged copyright violation(s) brought to our attention. Copyright disputes that arise between artists/designers whose patterns we sell must be settled by the parties involved and the appropriate legal authority. It is the sole responsibility of the parties involved to pursue such an investigation. Any actions by The Decorative Painting Store are those required by law.

If completed documentation of a counter notification of copyright infringement as outlined below is submitted, we will provide the documentation to the artist/designer who is originally filed a Notification of Copyright Infringement. They will have 14 business days from receiving the Counter Notification to provide evidence of taking legal action against the accused artist/designer in their original notification. If evidence of legal action isn't received by us within 14 business days, we will reinstate the patterns which are being disputed.

Counter Notification of Copyright infringement must include the following details. Until this complete information is submitted, we will be unable to take action on your request to reinstate patterns to our store:

Complete complaints require a physical or electronic signature of the copyright owner or a representative authorized to act on their behalf. To satisfy this requirement, you may type your full legal name to act as your signature at the bottom of your complaint.

Once documentation is completed and submitted to us, we will provide a complete copy of your documentation to the artist/designer you are claiming made the infringement, and the disputed patterns will be removed from our store. The two parties involved will then be responsible for any further action to resolve their issue.
