If completed documentation of an alleged copyright infringement as outlined below is submitted, we will provide the documentation to the artist/designer who is being accused and remove the contested patterns from our store. Removal of patterns being disputed should in no way be construed as our taking sides in the dispute, we are required to do so by law upon receiving a completed notice of copyright infringement. If the patterns involved in both sides of the dispute are in our store, both will be removed until the dispute is settled.
